

Message from Rabbi Karol D'var Torah for Installation Shabbat August 26, 2016

I - and probably many of you - have been thinking about what it means to be a leader, especially a good one. It's hard not to do that during the year of a presidential campaign.

I have also been thinking about the value of respect, and how it plays out in our community and society.

On August 23, a group of community leaders of which I have been a part held its first public program. The Interfaith Coalition for Compassion and Peace Village of Las Cruces co-sponsored a discussion entitled, "R-E-S-P-E-C-T - Find out what it means to...US!" The 40 Participants present split into small groups to discuss questions such as "What are behaviors that you respect? What are attitudes that you respect? How do you show respect? How does respect break down?" I can share the list of responses if you are interested, but there was one particular response that came to mind when I looked at a well-known passage in this week's Torah reading. We asked those present how we show respect in our immediate community (like a workplace, school or congregation). Two responses noted that we need to be aware of our "communal footprint" and to consider the implications of our actions. That means that, in whatever we do in communal life, we need to be aware of how our words and our deeds impact other people so that we can assure that our influence is positive or, at least, constructive.

Deuteronomy Chapter 11 verses 13-21, a passage in the Torah reading for this week, is known as the "second paragraph of the Shema," coming after the V'ahavta paragraph, in a traditional prayer book. Even more, it is the second paragraph on a mezuzah parchment. The significance of the mezuzah is that it is supposed to mark the home on the outside as a place where dedication to a specific heritage is happening inside the home. It is also a reminder, as we leave our homes, to take the best lessons we learn at home out into the world, so that our communal footprint leaves the world a little better on any given day because of our deeds and our presence.

What the section in Deuteronomy Chapter 11 actually says is that we should follow God's commandments. If we do, God will grant us the blessing of rain in its season. If we do not walk in the path in which God has directed us, there will be no rain. The passage then offers familiar reminders: bind them as a sign upon your hand, let them be a symbol between your eyes, and write them on the entrance to your home and on your city gate. Biblical scholars still debate whether these commands are literal or symbolic. In other words, it could mean the teachings of the Torah and our tradition should shape our vision, the way in which we look at the world with our eyes, and our actions, especially when our hands reach out to others in godly ways. The me-

zuzah itself means that there is something unique about our homes and this place, our spiritual and communal home.

So how do we practice these principles of our faith as we exercise leadership in this home of ours, Temple Beth-El? In our Tanakh study group this week, we read in chapter 11 of the book of Isaiah about that prophet's vision of an ideal ruler: "The spirit of the Eternal One shall alight upon him: A spirit of wisdom and insight, a spirit of counsel and valor, a spirit of devotion and reverence for the Eternal. He shall sense the truth by his reverence for the Eternal One: He shall not judge by what his eyes behold, nor decide by what his ears perceive. Thus he shall judge the poor with equity and decide with justice for the lowly of the land."

Wisdom, insight, counsel, fortitude, devotion or knowledge, and reverence for God and for all of life: these are central Jewish values. The passage then notes that these qualities enable a person to understand overarching truths, which heighten one's sense of fairness and justice. In such a context, all members of a community feel valued and included, and have their own chance to fully participate with leaders and peers alike.

In a commentary created this week for the Union for Reform Judaism, Lisa Lieberman Barzilai wrote about how congregational leadership requires sacred partnerships. What does that last phrase mean? She explained: "Being in sacred partnership means that we acknowledge our differences, just like the leaders of past generations did. At the same time, it means that we focus on our pledge and responsibility to the shared goals and common good of our congregation....Respect, trust, honesty, communication, transparency, confidentiality, and reflection are the tools we use to build and nurture sacred partnerships. Without these essential and interconnected components, fissures are likely to develop in the relationship....It's imperative that leaders be able to hear what others say, work to find common ground based on shared goals, and act to bring about an organization's shared vision."

So we do need to lead and act in such a way that what we do for and with one another will rain down blessing upon us as a community. We can develop a common vision and shared goals that will enable us to see one another in the most positive light, and to recognize opportunities for service to which we can apply Jewish values that can enhance our communal footprint individually and as a congregation. If we keep in mind these teachings of our heritage in our service to Temple and the greater community, we will write the best of our faith upon our doorposts, upon our gates, and upon our hearts.

President's Message September 2016

Well, we are facing the nitty gritty where the rubber is hitting the road, folks. As actions and decisions become imminent, congregants want transparency and explanations. As the President, I am working diligently to respond sincerely, profession-

ally, and appropriately. I work with every best intention for our synagogue and congregation. I communicate with the superb Dr. Ned Rubin, my Vice President, the dedicated Executive Committee, and then the wonderfully collaborative Board, regarding actions taken. Finally, I share the essence of our actions with the congregation in written and oral communication. My plan is to act thoughtfully, in an unbiased manner, and to be as diplomatic as possible in dealing with all issues that come before us.

Regarding the Rabbi's evaluation process, Ned and I, as your elected representatives, have chosen a group of very thoughtful, unbiased, and experienced individuals to review the feedback and observations collected. This review committee includes Sue Mazer, Patrick Quinn, Lionel Jacobs, Ned Rubin, and myself. We all have backgrounds in either Human Resources, evaluative processes of employees, and/or Temple Boards. Some of us may be newer to Temple Beth-El, Las Cruces, but we are not new to the process of employee evaluation or of Temple or organizational protocols, whether in government, education, or private enterprise.

Our group is not tasked with making a decision, but to sort the information collected that Ned and I will present to the Board and the Rabbi. We have established this review in accordance with point #11 of the 2014 Rabbinic Contract: "The Rabbi will receive a formal, oral performance review at least annually provided by a committee organized and chaired by the TBE president. The key points made during the oral review will be documented in writing following the meeting. The Rabbi is encouraged to provide performance feedback at least annually to the executive committee and the board."

Next, we selected congregants to interview from a wide range of the membership who have had significant life cycle experiences that involved interactions with the Rabbi and/or collaboration on a committee where the Rabbi's involvement has been integral. Everyone interviewed will be asked the same group of questions, which include the following: 1) On a scale of 1-5, in your capacity and/or experience with Rabbi Karol, how would you rate his performance with you? 2) You rated him a _____. What did he do well in supporting you to deserve that rating? Why did you rate him that way? 3) What would have to happen for you to move his performance rating up, from ______ to

We also encourage any of you who wish to share your thoughts about the Rabbi to write us a letter or send us an email. We have been announcing this in the weekly E-Blasts to ensure that everyone has the same opportunity. All of the information collected will help us to document the review of the Rabbi's performance. We will also ask the Rabbi to complete a self-

assessment. After all of the steps are completed, we will review the information, synthesize the results, and have a meeting with the Rabbi to give him an understanding of areas of strength and areas requiring improvement. We will also review the goals established at previous evaluations and establish any new goals based on the current evaluation for the upcoming year. After this is complete, a final report will be submitted to the Board of Trustees where new additional goals may be established as well as any other strategies to continue to build on the rabbi-congregational relationship.

Since this is a personnel review, it should be noted that the actual evaluation is confidential. However, all the goals and strategies agreed upon by the Board and the Rabbi will be shared with the congregation.

The performance review is completely separate from the decisions made by the Board of Trustees and the Congregation regarding our relationship with the Rabbi. Our Constitution states the following:

ARTICLE 13: RABBI-CONGREGATIONAL RELATIONSHIP

"The selection of the Rabbi and the relationship of the Congregation with the Rabbi shall be based on the Guidelines for Rabbinical-Congregational Relationships of the Union for Reform Judaism and the Central Conference of American Rabbis (CCAR), as adopted and recommended by the Union for Reform Judaism Board of Trustees and the CCAR in the fall of 1984 and reprinted and updated in the summer of 2002 so long as the Congregation maintains membership in the Union for Reform Judaism. The Constitution and By-Laws of Temple Beth-El supersede the Guidelines. The Board of Trustees will conclude a contractual agreement with the Rabbi covering all terms of employment. The contract may include specific exceptions to the Guidelines. The election, contract renewal and termination of the Rabbi are covered in the Constitution Article 7, Section 1."

In addition, our Constitution states:

ARTICLE 7: CONGREGATION

"Section 1: The Congregation alone has the right to elect a Rabbi, renew, or terminate his or her contractual relationship with the congregation."

This vote will take place after the High Holy Days in late October at a Semi-Annual Congregational Meeting.

Therefore, I want to assure you that the Rabbi Review Committee cannot make a decision regarding the renewal or termination of the contractual relationship with the Rabbi. We are just abiding by our contract with him, and completing a performance review, which is a best practice in any contractual relationship.

I continue to thank you all for your dedication and work on behalf of Temple Beth-El, to remind you to embrace inclusiveness and tolerance, and to continue working together to strengthen our Wisdom, Community Spirit, Tzedakah, and Sacred Purpose.

Yom HaShir-Day of Song Jewish Blues and more at Keystone Heritage Park Botanical Gardens in El Paso on Sunday, September 25th

Saul Kaye will bring his unique blend of Jewish blues to El Paso for an outdoor performance hosted by Congregation B'nai Zion at Keystone Heritage Park Botan-

ical Gardens on Sunday, September 25.

Saul was selected to be the headliner for the first Yom HaShir (Day of Song) after a diverse group of music enthusiasts listened to 10 candidates. Saul



has released CDs of various musical styles since the late 1990s, but he eventually found his calling when he pursued an idea that wouldn't leave him alone—the natural marriage of Jewish history, characters, and liturgy with the blues. He continued on this path of Jewish blues and recently released Jewish Blues Volume IV.

In addition to Saul's blues performance, local musicians will perform both original and classic Jewish music before and after Saul's 3pm headline set. You can also take advantage of the stunning Botanical Gardens—tours will be offered at 2pm and 4pm—or you can explore the Gardens on your own (just stay on the paths). Game stations will be sprinkled throughout the Gardens for those who are content with the music as background for other activities, and the Gardens has a children's corner with a maze and sandbox. The entrance is free, thanks to a grant from the Jewish Federation of Greater El Paso and to contributions from people who attended the Lag Ba'Omer fundraising concert, but sponsorships are available. The Sunday concert will be the culmination of Saul's trip to El Paso from San Francisco. 

Webmaster Update—From Bob Kimball

At the end of 2015, the Temple changed email servers. For the most part this transition was transparent to congregants, but for the Rabbi and a few others is was a stressful time. The Temple's email now resides safely on the Microsoft 365 cloud.

This transition offered some unexpected benefits:

- First, Microsoft provides accounts to non-profit organization at greatly reduced rates. The transition turned out to be a significant cost saver.
- Second, we gained access to cloud storage so our important documents are now securely backed-up off site.
- Finally, we were able create a "family" of email addresses that allow congregants to contact temple officers without knowing their personal email addresses.

We have an amazing opportunity from the Jewish Federation of El Paso, of which we are members. They are offering a grant proposal, which is due by September 30, at 2:00 pm. TBE member and Federation Board Member Bill Stein attended their required grant-writing workshop in August, which made us eligible to write a grant for anywhere from a few hundred dollars to upwards of \$50,000. Please review the attachments for more information. We need to meet the objective of their Mission Statement, which is pretty broad: "The Mission and Purpose of the Federation is to raise sufficient dollars to enhance the quality of Jewish life in the El Paso-Las Cruces area and overseas and to enable Jewish organizations in Greater El Paso to provide Jewish-oriented cultural, educational, social and recreational programs and services. The Federation's activities in furtherance of this purpose shall include, among others, an annual contribution campaign, the maintenance of endowment funds, recreational activities, and the coordination of social welfare and education activities within its area of operations."

We need several congregants, committee chairs, and/or board members to step up and work with Bill Stein to come up with a potential grant proposal idea and to participate in several grant writing sessions to be able to secure some very needed and very available funds to support a useful, educational program for Temple Beth-El. Our understanding is that almost \$200,000 is available from our affiliate, the Jewish Federation of El Paso, and that they disburse these funds annually, with almost every proposal being funded. We need to take advantage of this wonderful opportunity. One suggestion is to fund a speaker series that could take place throughout the year, bringing in multiple "big names" in Reform Judaism to speak and present to our congregation, community, and religious school students on weekends throughout the year. ISRAEL UPDATE

AN ISRAELI ARAB WOMAN SPEAKS HER MIND by Phil Alkon

Israel boasts the most demographically varied population in the Middle East. Unlike other Middle East nations, however, all its citizens have full individual political and civil rights, and none are persecuted, imprisoned, exiled or executed owing to religious, ethnic or group identities. Yes, the overwhelming majority of Israeli citizens are Jewish, but are hardly a homogenous bloc in any respect. They famously represent a wide array of geographic, cultural and religious identities. The 25% of the non-Jewish citizenry is also exceptionally diverse, perhaps not surprising given the country's unique humanitarian, ethical and democratic foundations. Arabs comprise 80% of Israel's non-Jewish citizens, and vary greatly in history, geographic origins, cultural traditions (e.g., urbanites, villagers, Bedouins) and religious beliefs and practices. The majority fall under the Sunni Muslim umbrella, but there are significant Christian, Druze, Bahai and other non-Muslim minorities as well.

Although the media (and much of the World) obsesses over the "occupied" Palestinians in the West Bank and Gaza, scant attention is given to the progress of the roughly 200,000 Arabs who remained in Israel following its creation in 1948. They and their descendants comprise the foundation of Israel's present Arab citizenry that now number 1.7 million. Arab Knesset members comprise the third largest bloc of Israel's parliament, and vigorously pursue policies that promote the economic and social status of their constituents. Over the years, Arabs have increasingly identified with and shared in Israel's trials and accomplishments. One indication is the frequency with which Israeli Arabs are openly expressing their support of Israel and expanded Arab participation in all aspects of Israeli life. A prominent individual example is Sarah Zoabi, a charismatic Muslim resident of Nazareth who has earned fame as a Master Chef and host of a regular cooking show on Israel TV. Here is some of what this courageous, insightful "hero of Israel" has to say.

I define myself as an Arab, Muslim, Israeli and Zionist. I support and believe with perfect faith in the right of the Jewish people to have a country of their own in the Holy Land, the land of Israel.

I'm loyal to the country, which gave me citizenship from the moment I opened my eyes. I'm loyal to the country which gave me everything. I'm loyal – not an ingrate – to the people who give me warmth, love and support.

The state of Israel is a democratic country which has

equal rights for all. A million Arabs live in the State of Israel with the Jews, and they aren't suffering like what happens to Arabs who are ruled by other Arabs. We see what happens in Mideast countries, how Radical Islam conquers every area. How they slaughter hundreds of thousands. How millions are turned into refugees and innocent children into orphans. How they divide countries.

Radical Islam is the false religion. They stole the religion from us. What they do to people is brainwashing. Radical Islam is a cancer which spreads in the world. And we need to find a solution for that cancer, to find a cure. Not to give in to them. Not to let them determine our lives. Don't let our country surrender to barbarism. First of all, not to give in to extremists. The more we give in, the more they'll attack us. Giving in, in the terrorists eyes, is a green light and opportunity to attack. Terror and a terrorist who is going to attack doesn't differentiate between me and you. If we're on a bus, what happens to you happens to me. So through fire and water, we're in this together. Terror doesn't come from discrimination, from frustration, or from "occupation." Terror comes from a murderous ideology, from education, from a culture of death. The purpose of terror is not "to gain independence." Rather it seeks to ruin and destroy the Jewish state.

We need to make known the voices of "sane" Arabs and moderate Islam. Because there is a moderate Islam. And there are normal Arabs who want to live quietly, in peace and love, with the Jews.

I want to say to all Israeli Arabs. It's time to wake up. We are in a "paradise. To compare us to other Arab countries, we are in paradise. Personally, I have no other country. I have no other flag. I've received a number of calls from Arabs who admire my courage and support me. There are those who say, "Good for you." "You're right." "We have no other country." "It's true! Every word hit the nail on the head!"

I want the whole world to know that the State of Israel is the source of much good in the world. It is a country that honors human rights, in spite of all it goes through from terror. That's my mission. And I won't give it up.

Temple Board of Trustees Meeting Summary - August 18, 2016

Bill Stein presented information from the Jewish Federation Workshop in El Paso regarding issuing grants to further the Jewish community. Last year a total of \$155K was dispensed in grants. The Federation wants to dispense all its funds every year. The grant proposals are due Sept. 30, 2016. The funds will be available January 2017 to be spent within the calendar year. Ellen suggested a scholar-inresidence program or something related to social action. A motion was made and seconded that an ad hoc committee be established to develop a grant proposal from TBE. The motion was passed.

Mark Saltman, Chair of the Security Committee, provided a detailed report of actions taken by that committee. He recommends providing education to Sunday School teachers and students on security issues and measures. The committee will get with the Las Cruces Police Department to make arrangements for training.

Michael Mandel addressed TBE's participation in a booth at the Renn Faire to sell pastrami sandwiches and other items. Plans are moving forward for TBE to run the booth on Sunday, and to have the Center for Spiritual Living have the booth in their name on Saturday while providing volunteers to serve that day.

The Acquisitions, Specific Gifts, and Aesthetics Committee has been researching a new front door to the Temple, and made a recommendation to the Board to go with a beautiful new door by Artistic Entryways at a cost of \$13,454. The money for this project will come from a recent bequest to our congregation.. A motion was made and seconded to accept this recommendation. The motion carried.

Rabbi Karol has been in conversations with Washington, D.C. based singer/guitarist Robyn Helzner, who recently contacted him about coming to Las Cruces on Monday, January 23 (after appearing at a program in Phoenix the night before). She would present her program "Kreplach and Dim Sum – Yes, there ARE Jews in China!", based on her experiences serving Jewish communities in that part of the world. Rabbi Karol saw her offer this presentation at Congregation Albert in Albuquerque in April and said that it was excellent. The Board approved the date of the program, which will take place at 7:00 pm on that day. Be watching for more details about this event in the coming months!

A discussion was held on our membership with the Union for Reform Judaism (URJ). Dues are currently \$5400, which will be difficult with our current budget. Board members proposed reducing TBE's pledge, and a motion was made and seconded to reduce the pledge to \$4000. The motion carried. The Board is also evaluating the benefits of URJ membership, and the next meeting will include a discussion about how we can take full advantage of the services and benefits offered by URJ membership.




