## President Board Report: November 16, 2017

## **Revisiting our Board Goals:**

At our May 7 Board Training, we took the day to do some needed self-reflection through engaging in a variety of activities and discussions. We established important goals and an action plan for this coming year. At the training, we committed to accomplish the following:

- 1. We will assist the Rabbi in establishing an administrative task force—Jeff Brown has met with the Rabbi about this. We can also look at possibly consolidating some of our more administratively-oriented committees and consolidate their tasks under this umbrella. We have looked at these tasks and planned to come back tonight to discuss this more.
- 2. We are sharing personal stories and Board profiles in the Adelante that we hope will encourage congregants to become involved in leadership roles—Ned said he would write one for November, Dee will write one for December, and Pearie will write one for January.
- 3. We have established a leadership development training program to encourage congregants to become more involved in leadership opportunities. Under the facilitation of Jim Rosenthal, we are in the process of working together to develop a program that will reach out to the Temple community and encourage members to value becoming a TBE leader. This group is an ad hoc part of the Nominating Committee, and will help develop and support leaders for TBE now and in the future. Several Board members have stepped up to join this program—Pearie Bruder, Michael Mandel, Sue Brown, Jeff Brown, the Rabbi, and me. We have met twice and plan to meet again next Monday. This group will set the tone for leadership and governance into the future.
- 4. We made calls to recognize and thank our Temple volunteers and our members in general (in addition to the FestivUS event). I also encourage us to recognize new members again at the January 2018 Festivus dinner, like we did last year. It was well-received and helped appreciate our new members. We are ready to set up the Festivus planning team again as well, so let me know if you want to help join in the plans.
- 5. We have not yet established focus groups to discuss people's concerns, but I have contacted Renee Frank about her ideas for the Strategic Planning Committee, the umbrella under which the focus groups could live, as she said she would work on this. I will let you know when I hear back from her.
- 6. Our Norms, which we've written at the beginning of the past two fiscal years, represent a Board Covenant or Brit Avodah to clarify expectations and responsibilities of Board members.

#### **New Board Secretary**

As you may have heard, Diane is going to step down from being on the Executive Committee, and I have asked Jeff Brown to take her place. I just wanted to get your formal approval for this action. Do we need a motion or a vote or just a general approval? I also want to thank Jeff for jumping in and organizing the committee reports and most recent minutes and agenda.

## **Repayment Due to BETY: \$417.19**

advanced for expenses incurred during a youth group trip to Phoenix. BETY advanced funds to then-advisor Andrea Orzoff. BETY took this out of its own bank account and now needs to be reimbursed. Leora provided Allen receipts last spring. The reimbursement can no longer be delayed.
