Minutes from Temple Beth-El Annual Membership Meeting June 20, 2024

Invocation by Diane Fleishman, newly elected Board President.

President's Report: Diane Fleishman is researching how to rent the temple for extra income. The Social Action Committee has moved the potential invitation to speaker Noa Baum to either March or April; invitation will be possible if the committee can secure funding through the Community Foundation and Jewish Federation (TBD around September or later). The First Friday Shabbat program was very successful.

Rabbi's Report: Sadly, the Baudo family's home in Ruidoso was lost. Rabbi Evette Lutman asked for support for son Eli's Bar Mitzvah previously planned for the coming weeks. The Shavuot service and study went well. Adult Ed classes are on hiatus for the summer as many are away on vacation; participants will plan a Mini B'nai Mitzvah event in January. Religious Practices Committee will ask individuals to take on roles in services including aliyahs. Rabbi seeks to re-initiate a phone tree.

Treasurer's Report: Joel Siegel revisited the discussion of 2024-25 budget as presented at the Annual Meeting in May 2024. There is a projected deficit of about \$60,000. A 5% dues increase would generate about \$6,000. Joel made the motion to accept the budget with a line-item dues increase of 10% to increase income by \$12,000. Jeff Lewis seconded the motion and it passed unanimously. Discussions about communication and potential for future increases ensued.

Infrastructure: Joel Siegel provided an update on the shade structure for the Biblical Garden. Funds have been secured and cost estimates are being researched. Soon, pledge donations will be taken from PayQuiq instead of PayPal to integrate with the Rakefet database system. Jeff Lewis and Joel Siegel will serve as the first line of contact for Mesilla Valley Alarm if triggered at the temple. Board gifts for the B'nai Mitzvot have been purchased.

Security: Jeff Lewis reflected that the actions taken after a threat was made to the temple in early June were correct. We need to take these incidents seriously in this climate and let the experts, i.e., Police and FBI lead in keeping our facility and membership safe. Mensch club members at Shabbat services have been asked to use the

two-way radios. The Rabbi voiced concerns about well-meaning congregants inviting the guards to have food from the Oneg while on duty. All felt that this is a nice thing to offer but they need to remain outside and on watch.

Strategic Planning: Diane relayed that we will implement all we can from the 2018 Strategic Plan. She will form a two-year Strategic Planning Committee to look at both financial needs and ways to better engage our membership.

Committee Reports were submitted by Religious School, Membership, Religious Practices, Library, Sisterhood, and Social Action. Membership and Religious School requested regular updates to the TBE website to attract new members and families. Social Action requested financing from Batkin and Kane Funds to help host speaker Noa Baum. The Library leadership looks forward to working to improve the library after Labor Day when they are back in town. Sisterhood is planning a brunch on July 14. The Religious Practices Committee asked the board to be present at services and call friends to encourage them to come as well. Thank you, Committee leaders!

New Fiscal Year, New Increased Member Assessments

For the last 15 years by some accounts, Temple Beth-El has not requested a voluntary increase in pledge payments. Inflation has caught up with us, not to mention the cost of our part-time Administrative Assistant and regular security presence, and we need your increased support. Member statements going out after the new fiscal year beginning July will show a suggested ten percent increase in your assessment above the amount to which you currently commit.

Remember that we derive most of our income from membership and the rest from fundraisers. Unlike other congregations that have standard membership rates based on a demographic (single, married couple, student, family, retiree, etc.), our rates are based only on guidelines and an honor system. In that regard, please review the current guidelines. If you can bring your pledge up to the guideline, please do! If not, please consider increasing your pledge by what you can. This coming year, we are facing another fiscal challenge. Increased pledge revenue will not close the deficit but is a good start.

We all know the reason we're here: a beautiful place to worship, a full time Rabbi, celebrations of holidays and life cycle events, mutual support and friendship, special events, a religious school, educational opportunities, and community involvement, to name a few. But remember, pledges are a form of Tzedakah (sharing), as in the Tanakh (holy scriptures) Malachi, Chapter 3, verses 7-10: "Turn back to Me and I will turn back to you – said the LORD of Hosts. But you ask 'How shall we turn back?' Ought man to defraud God? Yet 'you are defrauding Me. And you ask 'How have we been defrauding you?' In tithe and contribution. You are suffering under a curse yet you go on defrauding Me – the whole nation of you. Bring the full tithe into the storehouse and let there be food in My House, and thus put Me to the test – said the LORD of Hosts. I will surely open the floodgates of the sky for you and pour down blessings on you."
