Minutes from Temple Beth-El Annual Membership Meeting May 16, 2024

Treasurer Joel Siegel called the meeting to order at 7:09 pm, welcoming all congregant families in attendance which numbered 38 as well as a number on Zoom. The minutes of 2023 were approved.

Rabbi Evette Lutman presented an Invocation. Her message was it is a Mitzvah to be engaged in the business of the congregation and to not separate yourself from the congregation. The basis of her message was to "Hang in There" as we face challenges and work together as a cohesive group.

Joel introduced special guest, Kathy Nagle-Delgado, our new administrator. She said that she feels very privileged to work with us and the Rabbi. She thanked Joel who has trained and supported her through her training.

Membership co-chair Debbie Leyndyke welcomed the four new member families this past year and recognized them by name. One of those, Glenn Phillips and Linda Sweenie were in attendance.

Outgoing President Nan Rubin's report was included in the packet received by all members in attendance and by email. Rabbi Evette Lutman's report as well as Committee reports were also included in the packet.

Treasurer Joel Siegel presented a summary of this year's finances and projected budget for 2024-25. He reported that due to the extreme generosity of individuals and the congregation as a whole, we had a surplus this year. After some explanation, the takeaway message is that even though we have had a very good year it is not likely to be repeated.

He spent some time explaining how we can "Close the Gap" in our projected budget for 2024-25. As member pledges have not increased in at least 15 years, the Board has recommended a 5% increase, which will help but not cover the entire projected deficit. The new Board will meet in June to approve the budget and the pledge increase. They will also explore many other ideas to address the shortfall. The Board has made a commitment to develop a long-term strategic plan. There were many congregant questions which Joel answered.

Board and nominating committee member Mark Singer introduced the slate of new board members: Joel Siegel,

Donna Popky, Deb Leyndyke, Wendee Lorbeer, Diane Fleishman and Jeff Lewis. He explained that this year there are 7 positions to fill but only 6 nominees were introduced. He asked for any nominations from the floor. Debbie Levy entered her name for consideration. This slate was voted on and approved by acclamation for a new Board term of two years.

A slide show of photo highlights from this past year prepared by board member Sheri Spiegal was presented.

The meeting was adjourned at 8:50 pm with a motion by Diane Fleishman, seconded by Lynn Zeemont.

The new Board met following the meeting to approve and seat the following officers.

REGRETS: HOW TO LIVE WITH "IF ONLY"

Have you ever said to yourself "if only?"

It is a rare person who can say they have no regrets. Every choice we make requires us to leave other choices behind. No matter how good a decision is, there may be those moments when you wonder what it would have been like if you had made a different one. Decisions are about trade offs.

Like most things in life, regret has an up side and a down side. It can be a humiliating and debilitating process, but it can also be a tool for learning. You can learn from your mistakes to move forward, maybe in a different direction.

One of the things that fuels regret is perfectionism that is based on the myth of the ideal life. We live in a culture that tells us we are entitled to be happy and fulfilled all the time, that we shouldn't be frustrated and should have most everything we want. More of everything is being flaunted in commercials, advertisements and magazines. Products become outdated almost as fast they come off the assembly line for something bigger and better. Your expectations and demands about what your life should be can magnify your regrets because regrets are always comparing what you have with what you think you need.

Dos and Don'ts of regrets:

DOs:

Do normalize that we all make mistakes

Do focus on what you can learn, not on what you did wrong.

Do ask yourself what you were thinking when you made the mistake.

Do ask yourself what you were ignoring when you made the mistake.

Do ask yourself how you can use the information you have gathered.

Do ask yourself how you can avoid this mistake in the future.

DON'Ts:

Don't look back on your life and think of how much better off you would have been if you had done something else.

Don't dwell on all the negatives that you experienced and discount all the positives.

Don't idealize the choices that you did not make.

Don't insist that you should have known better.

Don't criticize yourself for not having known better.

Don't measure your choices by the best outcome that you can imagine.

Don't insist that you need to know everything before making a decision.

Don't expect a free lunch. Every decision involves some uncertainty and compromise.

Reflection: You don't have to make decisions

based on avoiding regret or by pursuing the perfect answer. Living in the real world requires compromise and settling for less than perfect.

Today's Practice: Recall a decision you made in your life where you had regret but after a while you found the good that came from it.


